## **European Directive on use of interpreters**

Next month the European Directive on the 'right to interpretation and translation in criminal proceedings' becomes law. The legislation aims to improve the protection of individual rights by developing the minimum standards for the right to a fair trial and the right of defence guaranteed by the European Convention for the Protection of Human Rights. The Directive also requires each member state to establish 'a register or registers of independent and appropriately qualified interpreters and translators', underlining the importance of NRPSI as the UK's independent register and regulator.

## PI4J participate in MoJ workshop

On 3 September, Professional Interpreters for Justice (PI4J) representatives took part in a workshop looking at quality in the context of interpreter services in the justice sector at the invitation of the MoJ. The feedback and points
