Working in immigration and the OISC

NRPSI has engaged with the Office of the Immigration Services Commissioner (OISC) to explain the role of professional interpreters and the value of the National Register. OISC had previously thought that interpreters provide 'advice', meaning that any interpreter working in immigration should register their services with OISC. Once we advised OISC that registered interpreters adhere to a Code of Conduct that explicitly precludes them from giving advice, we received confirmation that neither interpreting nor translation alone would be considered to be providing immigration advice and therefore that there is no need for interpreters to register with OISC. West Mercia and Warwickshire Police vetting requirements

Please be advised that West Mercia Police and Warwickshire Police are now only using police cleared interpreters. To ensure you are considered for work with these police forces and to improve your employment opportunities, please register your police security clearance with NRPSI. Interpreters who are vetted through the national Contractor Vetting Scheme are cleared to NPPV Level 3 as part of a National Agreement. If you possess this clearance, please also register this for inclusion on the National Register. Security clearance update

Please be aware that we will shortly be removing CRB security clearances dated 2009 from Registrants' records. If this results in you having no clearances on your record, please provide an up-to-date clearance. NRPSI recognises the problems interpreters have obtaining clearances because they are self-employed, as those offered by the Disclosure Barring Service (DBS) can only be applied for via an employer/client. We are continuing to engage with the DBS to address this issue. We also intend to readdress this matter with the Ministry of Justice under the new administration. See online for further details of the clearances we are able to accept. Please don't wait for NRPSI's official reminder, as obtaining clearances can take time. If you already have updated clearances, you can provide them to us at any time to add to your record, making it more attractive to potential clients.
