



Professional indemnity insurance via Towergate Insurance

Research into interpreted police interviews with children

Sheffield Hallam University is currently carrying out research (funded by the International Investigative Interviewing Research Group (IIRG)) into interpreted police interviews involving a child victim/witness of a crime. The researchers plan to develop guidelines and a short educational video on how interpreters and interviewers should work together when interviewing child victims or witnesses of alleged crimes.



Update on National Register user stats

Since our last **user stats update** in issue #69 of the Registrants' Newsletter, the number of organisations registered to search the National Register has increased by 15% to almost 3,000. There are more than 10,000 individuals registered to search from these organisations, leading to 7,500 searches for interpreters on the Register on average every month.

CPD event for interpreters on modern slavery, 3 June 2019

NRPSI and the **Association of Police and Court Interpreters (APCI)** are working with the charity **STOP THE TRAFFIK** to provide a half-day CPD event on modern slavery aimed at interpreters. STOP THE TRAFFIK is working to prevent human trafficking globally through its innovative intelligence-led approach, by empowering communities and disrupting trafficking at its source. Validity of DBS certificates

While the Standard and Enhanced **clearance certificates provided by the Disclosure and Barring Service (DBS)** do not display an expiry date, NRPSI registration requires Registrants to obtain an updated clearance every five years (from the issue date on their last certificate). If you have a DBS certificate that was **issued in 2014** on your record, now is the time to supply an updated certificate. Please note, there is no need to resend clearances dated after 2014 that already appear on your record. To check the clearances on your record, simply type your Registration Number into the 'Verify registration' box that appears on every page of the NRPSI website, or log in to your Interpreter's Room, to view your online profile.
