### NRPSI joins European-wide register project

I am delighted to announce that NRPSI is a founder member of the consortium, involving 10 partner associations from Europe, proposing to work on a pilot project to produce a European database of legal interpreters and translators.

Benefiting from the coordination of Lessius University College and under the EULITA umbrella, the 'LIT Search' project is a direct response to a new EU Directive 2010/64/EU regarding the right to quality interpretation and translation services in criminal proceedings.

The ultimate goal of the project is that any judicial stakeholder and EU citizen in a Member State can, using reliable and comparable parameters, search the national member directory of legal interpreters and translators in another Member State via the e-Justice portal. This will not only speed up the search and recruitment of legal interpreters and translators across borders, but will also help to assure the standard of service provided.

The proposal has been submitted for funding and, if successful, work will start in 2014.

### Advance news of redesigned website for NRPSI

The new NRPSI website has been expected for some time, but unfortunately has been delayed due to various internal changes at NRPSI (see previous newsletters). However, I am happy to report that development work has recommenced and I am confident that Registrants and other users will think the wait has been worthwhile.
