Upgrade to Registrants' online record

We have upgraded the Registrants' online profile so that it more closely matches the information shown on the NRPSI Photo ID Card. The online record now shows the interpreter's registration expiry date and the status of each language they have registered. And remember that some Registrants have opted to provide more information about their professional background, which can be found by clicking on the orange 'Show More' link on relevant records.

Helping aspiring interpreters: Aspirant category

In order to help interpreters who are interested in entering the profession and registering with NRPSI, we have set up a new Aspirant category on our database. It is free, and means that we can provide the Aspirants with specific information on appropriate qualifications, gaining experience and issues relevant to the profession of interpreting. We have already had an Aspirant obtain an appropriate qualification and successfully register, and we hope this initiative will help to increase the number of Registered Interpreters available to the public services.
