#### NRPSI Annual Review of Public Service Interpreting in the UK 2014

We have started to update our Annual Review, published for the first time last year. We will again provide an analysis of the registration and complaints statistics. We will also introduce some new data, including the age profile of Registrants, the number of security clearances retained and a breakdown of DPSI qualifications held.



#### NRPSI website users reach 5.000 landmark!

The statistics for those registering to search the National Register have reached another landmark with more than 5,000 individuals registered at the end of June. These users are drawn from more than 1,300 organisations from across the public services and some private sector organisations as well.

## NRPSI at the Language Show Live, 16-18 October 2015

NRPSI will have an increased presence at this year's Language Show Live, the UK's biggest language event that takes place at Olympia in London. In addition to having stand 711 in the exhibition hall, NRPSI Practitioner Director Lalia White will be giving a talk entitled 'A day in the life of a Public Service Interpreter' as part of the seminar programme. NRPSI is also helping the organisers to arrange a panel discussion on 'Working as an interpreter in the



public services today', more details of which will be revealed in the coming months.

#### Security clearance update

In light of the increasing number of Registrants subscribing to the DBS Update Service, NRPSI is preparing guidelines on how this information can be used. These will be published on the NRPSI website in the next few months. A fundamental principle of the guidelines will be that NRPSI must be shown (or previously have been shown) the original disclosure that the DBS Update Service is checking against. It is always worth ensuring your NRPSI security clearance record is kept up to date. One Registrant recently reported that they had gained a new customer as a direct result of adding an updated clearance to their record.
