



### MoJ Language Services Contract

The Ministry of Justice (MoJ) published Contract Notice 2015/S 203-369044 in the Online Journal of the EU (OJEU) on 15 October for the Language Services Contract. The current contract with Capita TI comes to an end on 31 October 2016. The procurement is in four lots: Lot 1 is for the provision of spoken language interpreting, Lot 2 is for translation, Lot 3 is for non-spoken interpreting, and Lot 4 is for quality assurance. NRPSI has made a submission to the first part of the procurement process (the pre-qualification questionnaire (PQQ) stage) for Lot 4 in partnership with the FTSE 250 company Interserve. The Interserve/ NRPSI partnership will find out if it has been accepted into the next phase of the MoJ procurement in December. We have provided more information on the process in a specific **frequently asked questions (FAQ) document** that appears in the News section of our website.



### Wiltshire Police Interpreter Claim Form

Wiltshire Police has informed NRPSI that it has amended and updated its Interpreter Claim Form. Changes include the addition of two boxes: one for the interpreter to specify the 'police station or location' they were at when they were interpreting during an interview, and another for interpreters to include the 'payee name' in the bank details section. These changes will help to speed up the payment of claims. New claim forms are available from the custody suites in Swindon or Melksham.
