### Publication of Indicative Sanctions Guidance

The National Register has been piloting draft guidance to our disciplinary panels on setting the level of sanction when there is a finding against an interpreter. In practice this has been found to be useful in providing the criteria for panels to implement fair and consistent decisions. We are now making the NRPSI Indicative Sanctions Guidance publicly available for Registrants and the general public in the interests of greater transparency. [View a copy of the guidance.](#)

### Working in non-registered languages

The NRPSI Code of Professional Conduct states that Registrants 'shall, other than in exceptional circumstances, only interpret between the language(s) for which they are registered with NRPSI' (Clause 5.2). This can be a particular problem where the general public may consider languages to be similar, for example Farsi and Dari, and might assume that an interpreter in one language can automatically speak the other. We encourage Registrants to consider registering other languages they wish to work in, and only charge a one-time fee (currently £56) to register each additional language. If you are a Registrant also working in an unregistered language with the intention of registering that language, please inform our Professional Standards Department by emailing: [psd@nrpsi.org.uk](mailto:psd@nrpsi.org.uk). Note that there have been **recent cases of complaints** being made under Clause 5.2.
