



## June 2012

- \* **Appointed a new Executive Director**

## July 2012

- \* **Launched an Amnesty Programme** to help interpreters re-join the Register
- \* Embarked on a communications campaign to highlight the critical importance of professional standards and of using a qualified NRPSI registered interpreter

## September 2012

- \* **Provided a written submission to the Justice Select Committee inquiry** into language services supplied to the MoJ under the FWA
- \* Reviewed and commenced development of the NRPSI website and search engine to make both more user-friendly and efficient. New look website coming 2013
- \* **Presented at Public Service Interpreting and Translation Network Group Conference**



## October 2012

- \* **Appeared before the Justice Select Committee** alongside colleagues from the PIA and ITI representing the Professional Interpreters for Justice Campaign
- \* Presented at Eulita's TRAFUT Workshop in Antwerp about the new Directive 2010/64/EU on the right to interpretation and translation in criminal proceedings

## December 2012

- \* **Met with the Justice Minister** as part of the Professional Interpreters for Justice Campaign

## Plans for 2013

1. Continue improving the operations of the Register
2. Continue communications campaign specifically targeting sectors such as Solicitors, Police, Health Services and Local Authorities to promote the importance of professional standards, using registered interpreters, and the role of the voluntary regulator in maintaining standards
3. Continue to campaign for the use of registered interpreters in the Judicial sector
4. Review the NRPSI Code of Professional Conduct
5. Develop and update guidelines for the users of interpreting services
6. Develop a formal Education and Qualifications Committee
7. Develop a scheme to recognise Continuous Professional Development
8. Complete development and adoption of our corporate governance document.
