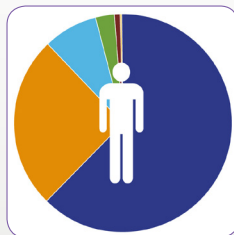
Code of Conduct CPD event with LMU

NRPSI Annual Review of Public Service interpreting in the UK 2015

The new edition of our **Annual Review** will be published tomorrow. All Registrants will receive an email notification and link in order to be able to view and download a copy. The review shares independent analysis of the information held on the National Register. It is sent to the major public services and policy-makers in government to keep them informed about the interpreting profession. Critically, it serves to underline the vital role that registered interpreters play in ensuring the smooth running of the UK's public services.



Security clearance: The DBS Update Service

NRPSI is now regularly carrying out **DBS Update checks** with the permission of Registrants. Where we can do this, Registrants are able to display a security clearance that is less than one year old on their online record. Upgrade to online record

We have upgraded the online profile so that it more closely matches the information shown on your NRPSI Photo ID Card. Your record now shows your registration expiry date and the status of each language you have registered. There is still also the potential for you to **'Show More' on your online record**, including your CPD record, which will be of interest to prospective clients. Updating changes in nationality

NRPSI will be keeping the Government informed of the **potential implications of the EU Referendum Brexit vote** on the public service interpreting profession and public services. In particular, we are concerned about the potential impact if residency status is not granted to interpreters holding EU nationality. If you have changed your nationality from that recorded on the National Register (which you can check via the Interpreter's Room), please provide the appropriate evidence of your new nationality to our Registration Team. It is vital that the National Register carries up-to-date information so that the figures we report are accurate.
