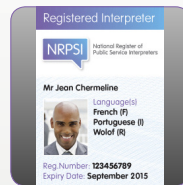
🔍 Threlford Memorial Cup nominations welcomed

🔍 Providing photographs for registration

**NRPSI requests that Registrants supply an up-to-date photograph of themselves as part of the annual renewal process.** This ensures that your clients can quickly and easily check your identity and credentials. Please do not send us an old photo or a copy of the same photo already on your record. We require a recent image that reflects what you look like at the point of renewing your registration. You can use a mobile phone to take a head and shoulder shot, or a public photo booth, or another method. The key thing is to ensure the image is clear and in focus. Photos can be emailed, or scanned and emailed, as an attachment (ideally as a jpeg file) to [admin@nrpsi.org.uk](mailto:admin@nrpsi.org.uk). Alternatively, you can mail a hardcopy to us and we will scan the photograph for you.
