NRPSI Annual Review of Public Service Interpreting 2013

We have now published our first review of interpreting in the UK and you can access a copy here:

The Annual Review will help to answer questions you may have such as ‘how many Registered Interpreters are there in the UK?’, ‘how many languages are available on the Register?’ and ‘how many complaints about interpreters does NRPSI receive?’.

Also, if you come across interpreters who are not registered, please encourage them to contact NRPSI, as it is in all users' interests to increase the number of Registrants. And finally, please mention NRPSI when engaging Registered Interpreters. It helps us to encourage more interpreters to join the Register.
